- a. IUCMA does not bind itself to accept the lowest or any RFQ, nor shall it be responsible for or pay any expenses or losses which may be incurred by the bidder in the preparation and delivery of the RFQ.
- b. No RFQ shall be deemed to have been accepted unless and until a purchase order/letter of appointment is prepared and executed.
- c. Quotation shall remain open for acceptance by IUCMA for a period of **90 days** from the closing date of the RFQ enquiry.
- 1.1. IUCMA reserves the right to:
 - a. Not evaluate and award RFQ that do not comply strictly with the requirements of this RFQ.
 - b. Make a selection solely on the information received in the RFQs and enter into negotiations with any one or more of the preferred bidder(s) based on the criteria specified in the evaluation of this RFQ.

1. BACKGROUND

The Inkomati-Usuthu Catchment Management Agency (IUCMA) is a statutory body established in terms of section 78 (1) of the National Water Act, No. 36 of 1998, as amended (the Act). The IUCMA is a schedule 3(A) Public Entity and is required as such to manage its resources in compliance with the Public Finance Management Act, any other relevant legislation, and the Constitution.

The IUCMA is currently using the Mimecast application for securing and archiving its email logs. The Mimecast M2A and Mimecast Legacy Data Management have a user complement of 92 and 150 residing with the current service provider, respectively. Therefore, the institution seeks a competent Mimecast service provider with proof of accreditation to manage its Mimecast domain.

2. PURPOSE

The IUCMA hereby invite suitably qualified service providers to submit quotations and price offers for the provision of Mimecast email archiving services and the provision of annual renewal of the application for the term of five (5) years.

3. SCOPE OF THE SERVICE REQUIRED

4. DURATION

The duration of the contract will be for a period of five (5) years from the date of appointment.
